RESOLUTION ESTABLISHING CITY OF PORT JERVIS AS LEAD AGENCY AND DETERMINING THAT PORT JERVIS ZONING CODE UPDATE PROJECT IS A TYPE I ACTION AND WILL NOT HAVE A SIGNIFICANT ADVERSE IMPACT ON THE ENVIRONMENT

WHEREAS, the City of Port Jervis (City) is proposing adoption of the City of Port Jervis Zoning Code Update.

WHEREAS, the Project has been classified as a Type I Action as defined by the State Environmental Quality Review Act (SEQRA); and

WHEREAS, on August 19, 2019, the City caused a letter and Part 1 of the EAF to be sent to other potentially "involved agencies" and "interested agencies" (as these quoted terms are defined in the Regulations), indicating the City's Common Council's ("Common Council") desire to serve as "lead agency" (as this quoted term is defined in the Regulations) for a coordinated review under SEQRA of the Project; and

WHEREAS, each of the involved agencies or potentially involved agencies has agreed to or raised no objections to the Common Council serving as lead agency for a coordinated review under SEQRA of the Project; and

WHEREAS, pursuant to the Regulations, the Common Council has considered the significance of the potential environmental impacts of the Project by (a) using the criteria specified in Section 617.7 of the Regulations, and (b) examining the EAF for the Project, including the facts and conclusions in Parts 1, 2, and 3 of the EAF, together with other available supporting information, to identify the relevant areas of environmental concern, and (c) thoroughly analyzing the areas of relevant environmental concern.

WHEREAS, Part I of a Short Environmental Assessment Form (SEAF) has been completed, reviewed by the City of Port Jervis Common Council, and will be circulated to all Interested and Involved Agencies for purposes of establishing the City of Port Jervis Common Council as "Lead Agency" in accordance with 6 NYCRR Part 617.6(b).

NOW, THEREFORE, BE IT RESOLVED AND DETERMINED, that the Common Council hereby establishes itself as lead agency for the Project; and

BE IT FURTHER RESOLVED, that based upon an examination of the EAF and other available supporting information, and considering both the magnitude and importance of each relevant area of environmental concern, and based further upon the Common Council's knowledge of the area surrounding the Project and such further investigations of the Project and its

potential environmental impact as the Common Council has deemed appropriate, the Common Council makes the following findings and determinations: the Project constitutes a Type I Action; and no significant adverse environmental impacts are noted in the EAF for the Project and none are known to the Common Council. Therefore, the Common Council hereby determines that the Project will not have a significant adverse environmental impact and will not require the preparation of a Draft Environmental Impact Statement with respect to the Project; and

BE IT FURTHER RESOLVED, that as a consequence of such determination and in compliance with the requirements of SEQRA and the Regulations, the Common Council directs the City's Mayor to prepare a Negative Declaration in accordance with 6 NYCRR § 617.12; and

BE IT FURTHER RESOLVED, that the Common Council directs the City Mayor to publish notice of and file a copy of the Negative Declaration for the Project in accordance with the Regulations; and

BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately

WHEREAS, a resolution was duly adopted by the Common Council of the City of Port Jervis on October 28, 2019, scheduling a public hearing to be held by Port Jervis Common Council on November 25, 2019 at 7:00 PM at the Common Council Chambers, 20 Hammond Street, Port Jervis, NY 12771, to hear all interested persons on a proposed Local Law entitled "A Local Law to repeal and replace the City of Port Jervis Code Chapter 535" and

WHEREAS, a public hearing was duly held on November 25, 2019 at 7:00 PM and all parties in attendance were permitted an opportunity to speak in support of or in opposition to said proposed Local Law, or any part thereof, and

WHEREAS, the Orange County Department of Planning on January 13, 2020, pursuant to Section 239-m of the General Municipal Law, determined that the proposed Local Law has no negative inter-community, or county-wide impacts, and

WHEREAS, pursuant to part 617 of the implementing regulations pertaining to Article 8 (State Environmental Quality Review (SEQR) Act) of the Environmental Conservation Law it has been determined by the Port Jervis Common Council that adoption of said proposed Local Law would not have a significant adverse impact upon the environment and could be processed by their applicable governmental agencies without further regard to SEQR, and

NOW, THEREFORE BE IT RESOLVED that the Port Jervis Common Council hereby adopts said Local Law as Local Law No. 1 of 2020 entitled "A Local Law to repeal and replace the City of Port Jervis Code Chapter 535," a copy of which is attached hereto and made a part hereof, and the City of Port Jervis Clerk-Treasurer is hereby directed to enter said Local Law in the minutes of this meeting and in the Local Law Book of the City of Port Jervis, and to give due notice of the adoption of said Local Law to the Secretary of State by filing the same with the Secretary of State as required by law.

For the Good of the City (Public Comment) -

Mr. Ed DeGroat aired his beliefs regarding 29-31 Front Street, Michelle Darne, documents he requested regarding the property and his opinion that the City made a bad investment. He expounded that the Mayor lies, and his legal counsel lies. He also brought forth the issue of Farnum Street.

Mr. Peter Grech apologized for the error he made at the December Council Meeting regarding Mr. David Bavoso again. He sarcastically thanked the Mayor for his persistence in choosing legal counsel. He also criticized the process of redactions, rules of conduct at meetings and lack of enough funds to achieve quality representation.

Mayor Kelly Decker – The Mayor requested a motion and a motion was made by Lisa Randazzo and seconded by Kristin Trovei to approve a contract with Barton and LoGiudice for the annexation in the amount of \$69,500. With \$10,000 to be provided from the City of Port Jervis and \$10,000 from the Town of Deerpark with the balance to come equally from the applicants with said funds already on deposit with the City of Port Jervis.

He announced that the VA Clinic Grand opening will occur on 2/11/2020 beginning at approximately 10am.

Mayor Decker noted that if anyone has concerns about topics being expounded on during public comment that you may feel free to contact any of the council members or his office to ask questions or obtain clarification given the repetitive nature of the issues brought forth as issue have already been covered.

The Mayor expressed his condolences to the family of Michael McCarthy and his numerous accomplishments in the community.

A motion was requested by the Mayor, made by Timothy Simmons and seconded by Maria Mann to provide 10 death certificates be provided to his family free of charge.

A motion was made by Lisa Randazzo to approve the appointment of Mr. David Bavoso as recommended by the Mayor as City Corporation counsel and seconded by Kristin Trovei.

Mr. Simmons detailed his displeasure at the actions of the Mayor with respect to seeking out additional possible candidates after the rejection of his recommendation at the last Council meeting.

Mr. Siegel expressed his desire to seek the best possible candidates for the amount we have budgeted and recommended seeking candidates outside of the City with a properly worded request.

Mrs. Trovei reminded the members of the process for appointment of legal counsel by the Mayor and that the search is left to the discretion of the Mayor. She reminded those present that William Bavoso had offered to continue with the annexation and serve as deputy counsel as necessary at no cost for the City. She also expressed that the annexation will be beneficial to both municipalities not the attorneys involved. She sees the appointment of David Bavoso as providing a smooth transition for the City.

Mrs. Randazzo echoed the comments regarding the Mayor's right to appoint and does not believe that we should leave ourselves unrepresented. She noted that never has the Council previously required an RFP nor has there ever been a call for changing the appointment rights of the Mayor.

Mr. Oney expressed his appreciation of passion on both sides of this issue. He however feels that it is clearly the Mayor's right and responsibility to appoint this position. He noted that while many sight that this is just business, he finds that untrue and notes that it is personal and about money. He admonished the Council that if you vote no then you are responsible for what happens afterward.

The Mayor stated that this issue is not about stubbornness it is about the law as prescribed by the Code and Charter. He noted that council members have independently done outreach to other attorneys without his input as opposed to working with him whereas every correspondence that was done by him was copied to the entire Council. He then read several emails he sent and received. He expressed his remorse at the feeling that he should be expected to work with attorneys unknown to him when he knows and respects the credentials of the person he is choosing to appoint. The Mayor asked the public to put in writing their opinions on this matter.

Mr. Simmons stated that an attorney that contacted him feels this whole thing is an exercise in futility if the Mayor is not wiling to work with someone else.

Mrs. Trovei spoke again and stated that she also spoke to the attorney Mr. Simmons mentioned and it was relayed to her that this person recognized that it is a Mayoral appointment and they will honor that by not submitting any further interest and feels that Mr. Bavoso is a capable attorney.

Mr. Siegel encouraged the public to express their opinions.
