Please understand that this cannot go for a vote tonight, as it was posted for regular Common Council meeting, it will need to be re- advertised for Zoom and can be voted on Monday, November 23rd, 2020 at the Common Council meeting. I'll turn it over to Kristin.

Kristin Trovei:

This is the hearing for local law number four, which is in regards to the tax cap override. I thought it was going to be postponed until next week, but as it was stated in the public notice for the public here, when we do it again on Zoom information, so the public will have a chance to log on, comment, question and express their concerns. I don't really have any new information about the tax cap override that hasn't been stated at the two other public hearings. It is just an ability to override the state impose tax cap, which is at 1.5, 2% as it stands. If the city wants to meet that, you would have to cut \$200,000 from our current budget proposal or add \$200,000 of revenue from somewhere or some combination of that. The override does not mean that we have to go over 1.5, 2%. It just gives us the ability to do so if we are able to meet that limitation that was put upon us. And that's the summary of the tax cap override.

Mayor:

With that said, is there anybody from the council that would like to say anything? Okay. Is there anyone from the public that would like to say anything?

Robin Waizenegger:

I will interject, that it is crucial to the annexation process to also pass the waiver.

Mayor:

Thank you. I'll entertain a motion to adjourn the local law, number four of 2020 proposed tax cap override until the Monday, November 23rd meeting at 6:31 PM.

Mr. Mayor, can we make the motion to continue the public hearing until that day, please?

Mayor:

Okay. To continue to public hearing?

We have no executive material to address. So, we'll go right into business and trust for police in ADA.

Regis Foster:

Thank you, Mayor. Let's see what some of the dates here, training initiatives, the department officers are being scheduled to attend advanced training during the month of November to cover topics, including implicit bias, cultural awareness and

diversity and autism shield for law enforcement, firefighters and EMS personnel. This is no shave November fundraiser. So, if you have noticed unshaven police officers lately, it's for a good cause. The members of the city of Port Jervis Police Department are participating in the no shave November fundraising initiative throughout the month of November to raise funding, to help bring the magic of Christmas to children and families who are economically disadvantaged. You've all received the October monthly report. So, I'd like to make a motion to have that approved.

Regis Foster:

Okay. Some of the highlights and total instances for the month was 901. Traffic stops was 37. Value of stolen property was \$3,581. Domestic violence, I was told the message for the month was 28. Prisoners detained locally was 11 and the total arrest for the month was 45. Part one offenses, there was 11 for larceny. Part two offenses, controlled substances, was 12 for the month and simple assault was 14. Also, tickets summary, parking tickets issued was three. Traffic tickets issued was 58 and traffic offenses unlicensed suspension was 18, speeding was five and stop signs and red-light violations was four.

Regis Foster:

Our next police committee meeting is going to be held on December 17th at six o'clock or hopefully in the Council chambers, we'll see where that goes, of course. But this month's meeting is canceled due to budget workshops. So, the chief is going to be phoning in on presenting his budget and so forth. So, we are going to conduct the police committee meeting or business on December 17th at 6:00 PM. ADA met and there's nothing really that went on in the ADA meeting except for status quo that they can look at the street signs, streets, making sure everything is ADA compatible. That was a quick meeting. Our next ADA meeting is going to be held on March 1st or no February. I'm sorry, February 1st of 2021 at 6:30 in the Council chambers. And that is all I have to report. Thank you.

I'm glad Jen called you.

So, what we're going to do is... We're going to reassess where Port Jervis is at with this COVID over the next week or two. And then we'll go from there. If those numbers come down and level off, we'll come back to have a meeting. Otherwise it'll be until, until what was it? December 4th or fifth or something like that.

William Frank:

Mr. Mayor, the current governor, his order for meeting remotely goes through, up to and through December 3rd. I have every expectation he's going to extend that for another 30 days.

Mayor:

We will reevaluate our in-person meetings, depending on where these levels are at, and I'll look at that.

Dominick Santini:

Okay. So, either it will be in-person or Zoom December 2nd, 6:00 PM.

Mayor:

Thank you, sir.

Dominick Santini:

That's all I have. Thank you.

Ms. Campbell.

Chandler Campbell:

Thank you, Mayor. The Youth Center will be closed this week of November 9th to the 13th. This includes the recreation room. All groups and organizations that use the center for meetings are also canceled. We plan to reopen Monday, November 16. The Little Chefs program at the Port Jervis recreation cooking class will take place this Saturday, November 14th at 10:00 AM. Our fall cleanup and casino trip have both been canceled and there's no makeup date for them at this time. When we reopen, please, I just want to send a reminder to social distance and wear masks at all times. Thank you for understanding and your cooperation. We look forward to seeing everybody on November 16th. The next Recreation Commission meeting is scheduled for Thursday, November 19th, at 6:00 PM. And that's all. Thank you.

Thank you very much. Ms. Mann, Port tourism and IDA.

Maria Mann:

Thank you, Mayor. The IDA has not met since their last meeting. Their next meeting was to be held on Monday, November 16th at 6:00 PM, but I'm not sure what the status is going to be with that being due to COVID and meeting remotely. Tourism has not meant since their last meeting. The board will not be meeting in person and will correspond via email. For any questions or suggestions, please email the tourism chair Laura Meyer at floralaurapj@yahoo.com. And that's all. Thank you, Mayor.

Thank you very much. Mr. Oney DPW.

Gerald Oney:

Thank you, Mayor. Glad you got to meet before this thing froze again. That was great. I'd like to say that garbage and recycling will be on its' normal schedule for the first and second wards. The third and fourth ward will be one day later due to the Veteran's Day holiday. Second ward papers will be picked up as normal on Friday the 13th of this month, this week. Leave pick up is continuing weekly with bagged and canned debris being removed first, loose leaves will follow in the next couple of weeks. Please be sure to tie up your brush in small 12-inch bundles. Also, yard debris needs to be left in a can of 35 gallons or less, or in biodegradable compostable bags. And I will say this that now we're under crunch time with the leaves. So, as you get them bagged, put them out, we're going to pick them up every day. Every day that we can. We're a little behind this week due to circumstances that we're all aware of, but if you bag them or have them in a can, get them out to the road and we're going to pick them up as we go. The loose leaf will be a couple of weeks from now. Hopefully there's no snow on the ground.

The next DPW meeting will be Monday, December 7th, at 6:00 PM in the Council chambers. And Mayor, on a personal note, I'd just like to thank the residents and voters in the third ward that supported me in this last election. You give me an opportunity to serve for another year. Thank you.

Mayor:

Welcome. Ms. Trovei. Finance and CDA.

Kristin Trovei:

Thank you. CDA met October 28, and due to two resignations, the board had to do a reorganization with the new members. The board is now as follows, Chair John Russell, Vice-Chair Kristin Trovei, Treasurer Gerald Oney Jr, Secretary Michael Talmadge. The rest of the meeting was focused on section 8 as well as reviewing in progress for us and the draft proposed budget for 2021 for the CDA.

Kristin Trovei:

Finance has not met since the last meeting. The next finance meeting will be before the budget workshop number three on Wednesday, November 18th at 6:00 PM for any pressing financial issues that need to be addressed. The budget workshop will begin approximately at 6:15 PM. At this time, all meetings are planned to be via Zoom, but of course, that could change and we will let you know, as soon as we know.

Even though there was no finance meeting, I do have some updates. Budget workshop number one was held.

Members present reviewed the budget lines for CDA assessor and DPW. No changes opposed at the workshop, so the draft 2021 budget remains at approximately 5% increase as I previously said. In order to meet the tax cap approximately \$200,000 must be cut from that budget. Budget workshop number two will be held Monday, November 16th at 6:30 PM. Budget workshop number three will be held Wednesday, November 18th at 6:15 PM, potentially via Zoom, we shall see.

The 2019 tax lien sale will go on as schedule next week on November 17 with a minor change of location instead of being in City hall and the Council chambers, it will be next door at engine two in the bay with the doors open to have a more open air environment to help decrease the spread of COVID with approximately 55 properties on the list. Masks and social distancing

will be required. So ,if you plan on attending that do not come to city hall. Go next door to the firehouse. Just as a FYI, 2018 tax lien is expiring. The last day to redeem them, if they're still on the list, would be Friday the 13th. Everyone received a copy of the October 2020 finance meeting minutes via email. And at this time, I'd like to make a motion to approve those minutes.

Thank you. We have bills to pay from the general fund, \$194,255.22. From the water fund, \$12,114.55. From the sewer fund, \$5,832.34. From the capital funds \$119,857.83. From trusted agency, \$129,404. For a total of \$461,553.94. Some of the larger items from the general water and or sewer funds, Orange County Commissioner Finance, collection of taxes, \$80,783.99. Partners in Safety for fire department physicals \$10,405. Orange County Truck Service for the fire truck repairs to engine number five, \$18,891.66. Orange & Rockland \$9,573.62. From the Capital Fund, Enterprises Inc. for the water plant tank repair \$32,828. For the liner for the sewer project, \$41,459.26. A Plus Striping Inc. for the crosswalk lines, \$17,250. I would like to make a motion to pay the bills.

Mayor:

Motion by Ms. Trovei. Do we have a second? Discussion? All in favor.

All:

Opposed? *Silence* So carried.

Kristin Trovei:

Thank you. I have here a resolution of the Common Council, the city of Port Jervis regarding 2021 holiday schedule. Thank you. And just a quick PJ Pride update here. We're doing a sticker shop with statistics about alcohol sales and drinking while driving at the Orange County DA's office on Friday, November 20th. At this time, they're planning a press conference at the government center at 4:00 PM with the sticker shop to begin around 2:00PM. That is all Mayor. Thank you.

Mayor:

Thank you very much. Mr. Simmons, Planning and Zoning.

Timothy Simmons:

Thank you. Zoning board met on Tuesday, November 3rd at 7:00 PM in the Council chambers in person. There was a pre-submission by KJB building LLC. They were seeking area variance for a rear yard setback for an addition to the office building. Most people would know this as Dr. Little's office on 11 Orchard Street. So, they're asking for a variance to extend the back of the building for greater office space and a more efficient use of the building.

They set a public hearing for Tuesday, December 1st. I'm assuming that will, unless things change quite a bit, that would be held in Zoom. That number will probably be, I would assume that number would be posted on the City website.

Mayor:

Yeah. So, when I do these meetings, just so everybody knows, I'm going to use this same number. This is our identifier number: 405 793 5811 and there's no password.

Timothy Simmons:

Okay, great. So as the Mayor just said, if you want to tune into the Zoning board meeting and, or make public comment, do it through that number. Planning has not yet met for this month. They will meet via Zoom Tuesday, November 17th at 7:00 PM. And that's all I have. Thank you.

Mayor:

Thank you. I will set those, those two meetings up. So, I'll send them out to Tom and to Tom and Tom, right? Yeah. Tom and Tommy. All right. Mr. Siegel, Fire Emergency management and housing.

Stanley Siegel:

Thank you. The last fire emergency management meeting was October the 19th. The next meeting of November 16th is canceled as we'll be discussing the fire department budget at 6:30 PM at the same time as we made it would have been held.

I have some secretary correspondence. We have one letter from the secretary. Appointment of a driver of James B. Fuller Jr. Dear Mayor Decker and members of City Council it is requested that firefighter James B. Fuller Jr. be improved as a driver for Excelsior Engine Company number five. This firefighter is tested in accordance with the proper requirements such as E block, pump operator, ladder operations, et cetera. As appropriate to the respect of vehicle by Chief, Dominic Cicalese to operate the fire apparatus. A copy of the member's driver's license was provided on an earlier date. The firefighter's driver's license information was previously entered into New York State department of motor vehicles, licensed event notification service. This service notifies the department upon the expiration and renewal of the driver's license, the suspension and revocation, the restoration of a driver's license, changes to the driver's license class and privilege, traffic convictions, reportable accidents, driver's license suspension revocation orders, completion of training course to reduce insurance premiums, changes to hazmat license endorsements, and changes to the med-cert status. The information to the extent that it hasn't been provided to the city's insurance carrier, the license should also be provided to them and they should be notified to add the firefighter as an additional driver of the apparatus.

Stanley Siegel:

Okay, I'll notify them. Thank you.

Housing authority last meeting was held on October 27th. The next meeting is on November 24th at 7:00 PM, at Hillside Terrace. And that will probably be Zoom, but I will notify people on Facebook. Veterans reminder again, to get your flu shot. You can make an appointment at the clinic, or you can go to a drive thru at Castle Point or Montrose, if you prefer that. But it's important that you get your flu shot, especially with the COVID situation. The Veteran's Day parade has been canceled for this year due to COVID restrictions and the ceremony at the park is canceled as well. The Elks Veterans dinner that they have annually for the veterans is also canceled due to COVID conditions in the area. I'd like to congratulate Brice Horner on his accomplishments at the United States Marine bootcamp. It's an honor to have someone from our community do so well.

The flag display for heroes is on the 15th at 2:00 PM. and that's rescheduled to that date. I would assume it's still on as the last word we got, and the warming station also opens on the 15th of November for those that need a warming station. And I believe that's it. Thank you very much. Stay safe.

Thank you, Mayor. I just want to also say thank you in advance to our veterans, since unfortunately we won't be able to see many of them this year, so we can just give a shout out to everyone there. And then also Jerry congrats. We're happy to keep you on board. That's all I have. Thank you.

Mayor:

So, Ms. Waizenegger, this offer we received, I want to send that to Finance first. Okay. Everybody got an email today of an offer for purchase property. That'll go to finance and as well as, unless you guys think further, there are three now quotes on the Franklin Street property. The first quote that we got was the lowest. Would you rather this go to finance? It's only two weeks that we can vote on it. Go to finance. Although finance, I know is only like 15 minutes long, but there at your pleasure finance. Okay.

Mayor:

Okay. I just want folks out there to... Also, as Mr. Siegel said, and Ms. Randazzo, please remember our veterans. Many people, many of our veterans struggle every day with different things in life. And they were willing to give up themselves to serve us so that we could be free. I know that people are struggling with the fact that there is no veteran ceremony. However, the Mayor's Facebook page will have a live broadcast, but it will only be about five minutes, maybe 10 at the most, of a broadcast. So, if you want to watch some type of veterans' ceremony. If you can't watch it at 11 o'clock, because it'll be on the 11th, which is Wednesday at 11 o'clock, otherwise it will be recorded on there so that you could watch at least some type of local ceremony.

As far as the Christmas tree lighting down at the promenade, that decision will be made at our next Common Council meeting. Again, we're just assessing the situation and where we're at. One thing. I just got a message about the police collaboration committee. Did you appoint people to that yet?

In light of what's been going on and I haven't honestly even looked at the properties. Unless the council wants to look at them and entertain a special meeting, I would just work out this year.

One more thing if I might. I might have missed it, but did we bring up the bell engine five's budget?
